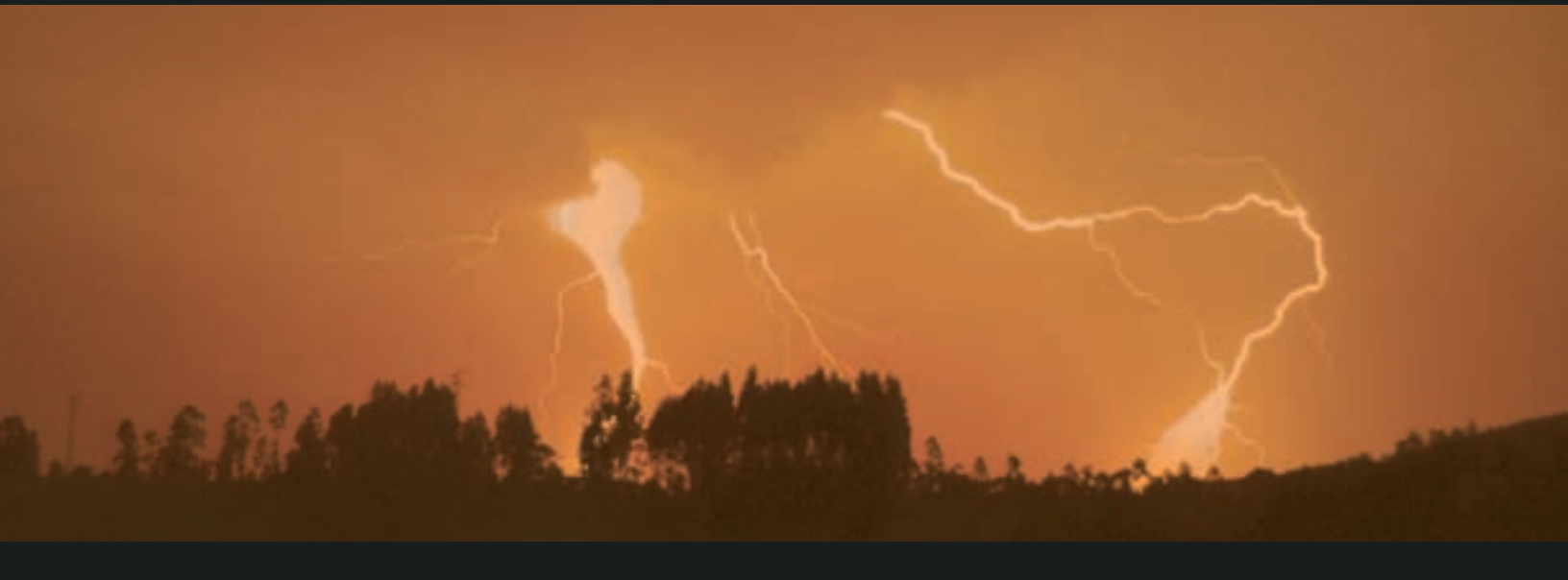

The eDiscovery amendments to the Federal Rules of Civil Procedure (FRCP) create a number of challenges for organizations doing business in the United States. Ensuring compliance with the federal rules creates great operational and organizational challenges and can be very costly. 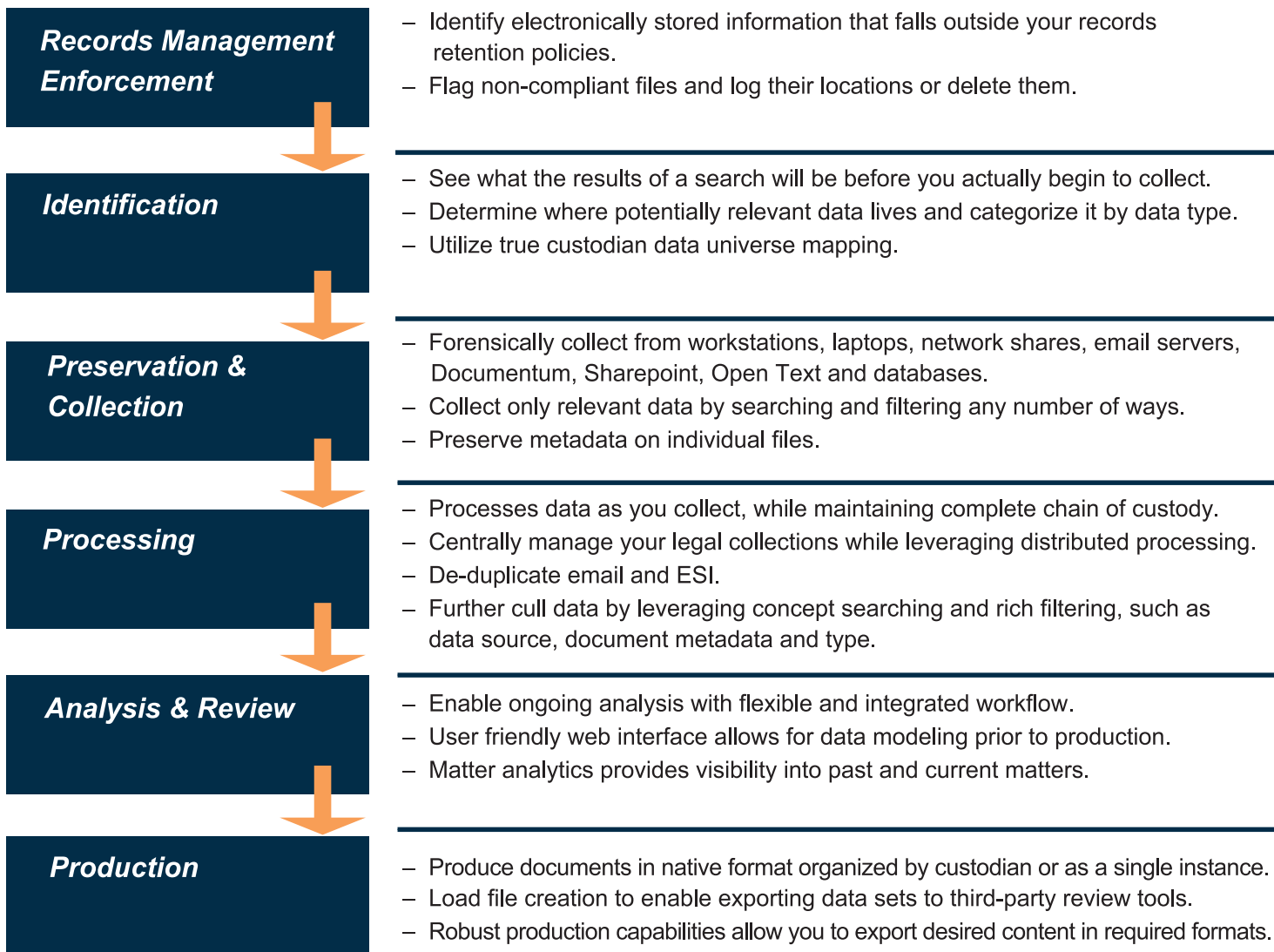

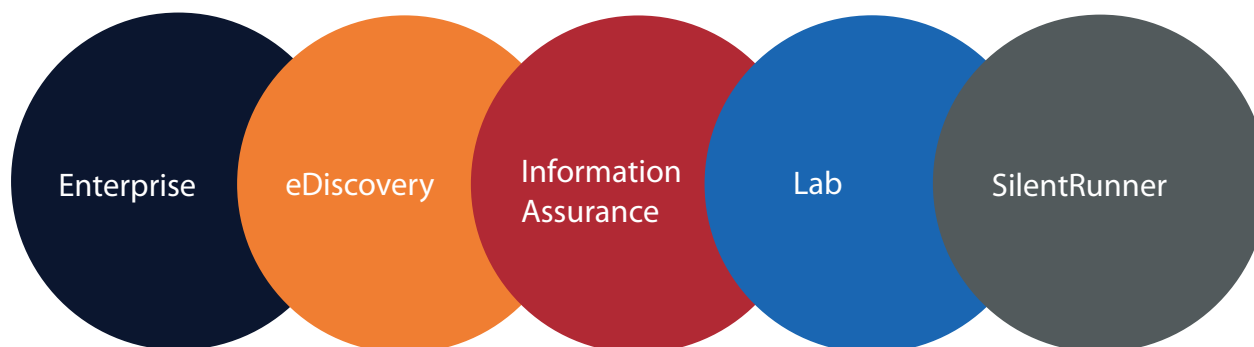
